INDIA WIN BRONZE ON OPENING DAY OF ASIAN TRACK CYCLING

NEW DELHI: India opened their account in the Asian Track Cycling Championships with a bronze medal in the junior women's team sprint event on the opening day of the competitions here on Monday. The Indian duo of Shushikala Agashe and Aleena Reji bagged the third spot after beating Korea in the third-fourth place race at the Indira Gandhi Indoor Stadium velodrome here. The home team clocked 36.677 seconds while the Korea pair of Jeong Seolhwa and Ha Jieun clocked 36.735 s. China then beat Chinese Taipei in the race for first and second places as the two teams clocked 35.819 seconds and 36.623 seconds respectively. In the qualification round, the Indian women's junior sprint team had finished third with a time of 36.743 seconds. "We are proud to have won a medal for the country, but we are a bit disappointed as we could have done better and finished second in the qualification. That would have given us a chance to go for the gold or at least we would have won a silver," Aleena Reji said. AGENCIES

जंग के अवशेषों में विस्फोट से हताहत हुए हैं। रिपोर्ट में कहा गया है कि वर्ष 2016 में हवाई हमलों में अब तक सबसे ज्यादा आम नागरिक हताहत हुए हैं।

कुल 590 लोग हताहत हुए हैं जिनमें से 250 लोगों ने अपनी जान गंवाई। रिपोर्ट के मुताबिक, संयुक्त राष्ट्र बीते आठ वर्षों से सालाना रिपोर्ट जारी कर रहा है और तब से लेकर अब तक संघर्ष में 24,841 आम नागरिकों की लोगों की मौत हुई है और 45,347 लोग जख्मी हुए हैं। सर्वाधिक संख्या (61 प्रतिशत) में लोगों को हताहत करने के जिम्मेदार 'सरकार विरोधी तत्व' हैं, मुख्य रूप से तालिबान साथ ही इस्लामिक स्टेट समूह।

14 पादरियों में से एक यौन शोषण का आरोपी

सिडनी, एफपी। ऑस्ट्रेलिया के गिरजाघरों में बाल यौन शोषण संबंधी एक जांच के जो आकड़े सामने आए हैं वह चौंकाने वाले हैं और उनका बचाव नहीं किया जा सकता। इनसे पता चलता है कि वर्ष 1950 से 2010 के बीच सात फीसदी कैथोलिक पादरियों पर बाल शोषण के आरोप लगे थे लेकिन इनकी कभी जांच नहीं की गई। 'द रॉयल कमीशन इंटर इंस्टिट्यूशनल रेस्पॉन्सेस टू चाइल्ड सेक्सुअल अब्यूज' को पता चला कि गिरजाघर प्राधिकारियों के पास बाल यौन शोषण के कथित 4,444 मामलों की शिकायत की गई जिनमें से 15 फीसदी से अधिक मामलों में आरोप पादरियों पर लगे। ऑस्ट्रेलिया ने देशभर में बाल यौन शोषण मामलों की जांच के लिए दबाव बढ़ा है।
